## **Construction Permit INFORMATION SHEET**

No person shall perform or authorize Construction or Substantial Improvement within the unincorporated areas of Ellis County without first securing a permit.

In order to obtain a permit, the following items must be submitted:

1. A completed Construction Permit Application.
2. Two sets of plans that establish that the design and construction of the spray room, spray booth or spray space is in accordance with Chapter 24 of the 2018 *International Fire Code*.
3. Spray booths and spray rooms shall be protected by an approved automatic fire-extinguishing system.
4. Portable fire extinguishers shall be provided in accordance with the requirements for a high hazard occupancy.
5. A permit fee in accordance with the Ellis County Fire Code.
